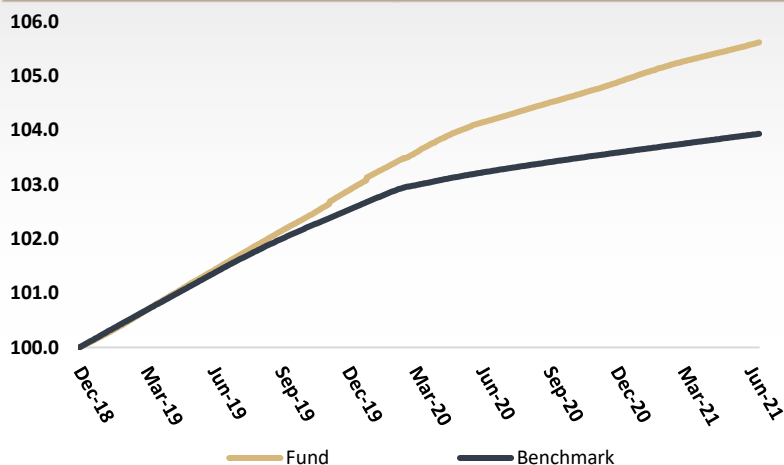

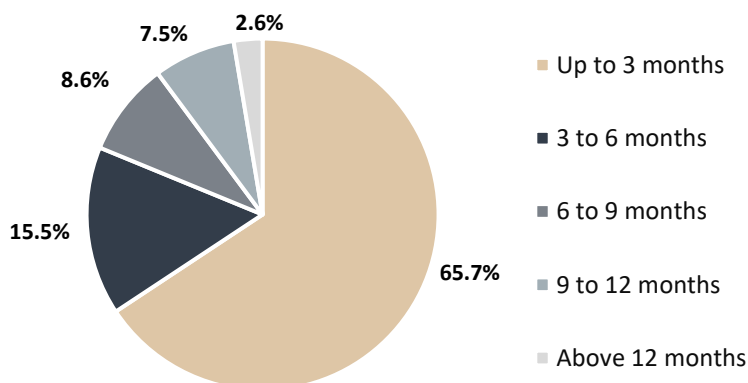
Performance Since December 31, 2018
