Performance Since Inception



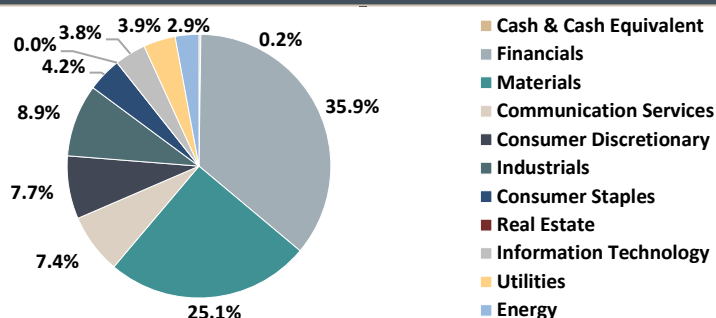

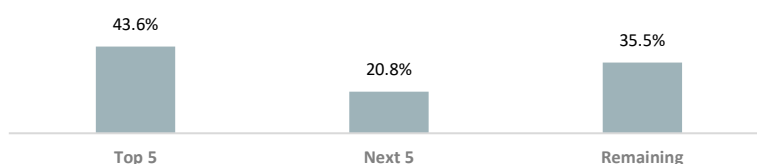
